## 1. Privacy policy

This privacy policy explains how grange media technologies ltd (trading as gmedia) use any personal information.

## 2. What information is being collected?

There are 3 reasons why we collect personal data:

#### 1. Staff Administration

Appointments or removals, pay, discipline, superannuation, work management or other personnel matters in relation to the staff of gmedia.

### 2. Accounts & Records

Keeping accounts related to any business or other activity carried out by gmedia, or to decide whether or not to accept a person as a customer or supplier.

### 3. Advertising, Marketing & Public Relations

Advertising or marketing the business of gmedia's activity, goods or services and promoting public relations in connection with that business or activity, or those goods or services.



We may collect the following information:

- Name and job title
- Contact information including email address
- Demographic information such as postal address, including postcode
- Other information relevant to customer surveys or offers, which could include relevant preferences and interests.

## 3. How we collect information about you

We collect information about you when you transact with us or register with us or make an enquiry about our products and services.

## 4. What we do with the information we gather

- Primarily, internal record keeping
- We may use the information to improve our products and services
- We may periodically send promotional emails about new products, special
  offers or other information which we think you may find interesting using the
  email address which you have provided

# 5. Security

We are committed to ensuring that your information is secure.

In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect.

We will not sell, distribute or lease your personal information to third parties unless we are required to do so by law.
